Explain: **The review area includes an approximately 150 acre parcel. The site is entirely upland agricultural ground except for three isolated wetlands located in and around a 7.5 acre woodlot in the southwest quadrant. Wetland A is 0.26 acre PEM, that is reported as prior-converted cropland (PCC) and located along the northside of the woodlot. Wetland B is a 0.48 acre PEM that is reported as PCC and located along the west side of the woodlot. Wetland C is a**

2.16 acre PFO located in the woodlot. There is a perennial stream, Jay Ditch, that flows along the western site boundary, but is not included in this JD. The identified wetlands are not within the floodplain of the ditch. There is no surface hydrological connection between the wetlands and the ditch. A county regulated drain tile is located south of the woodlot running east to west, but the wetlands do not extend to where the drain is mapped. Other non-regulated private field tiles were reported as likely being present on the site. However none were observed in the field investigation and any in the proximity of the wetlands are likely not functioning as wetland hydrology and other parameters are present. Any potential subsurface connection is speculative. The wetlands do not possess any hydrological or ecological connection to downstream waters, are not in any floodplain, and are not susceptible to use in interstate or foreign commerce. Therefore, the identified wetlands are isolated and not waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
