- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: Six potential jurisdictional waters were assessed within the 787 review area. These resources are identified as WL-1, WL-2, WL-3, WL-4, WL-5, and WL-11. WL-1, WL-2, WL-3 and WL-5 are all permanently flooded palustrine unconsolidated bottom wetlands which have been used as cattle ponds on the property. These features all receive hydrology from sheet flow from the surrounding agricultural fields, and lack vegetation due to their use as cattle ponds. There is no indication of a surface or subsurface connection to any other waters. W-4 is also a permanently palustrine unconsolidated bottom wetland with a narrow broad-leaved deciduous, palustrine scrub shrub (PSS) component on the fringe of the pond. This feature is physically isolated within the landscape and there are no indications of a surface or

subsurface connection to any other waters. W-11 palustrine emergent wetland located on a hill slope. This wetland receives hydrology from a high water table and sheet flow from surrounding agricultural fields. As the feature moves down the hill slope all wetland indicators are lost and there are no signs of a bed or bank or other indicator of hydrology as the resource moves to lower elevation on the site. There are no indication of a surface or subsurface connection with any other waters.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
