- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The site was investigated in October 2019, April 2020, and July 2020 and lacked hydrology even during the wet season. It is likely the adjacent mining operations have impacted the hydrology by lowering the water table.

B. Typical year assessment(s): [The APT was used to analyze precipitation and climate trends for each date in which a site visit was conducted \(10/2/19, 4/15/20, 7/15/20\). The delineation visit on 4/15/20 was performed during the wet season with above-average rainfall in the preceding 3 months; however, no signs of wetland hydrology were present during the investigation.](#)
