Wetland 02	0.05	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 02 is located in what appears to be an excavated cut area that was part of rough site grading around 2010. It is approximately 0.52 miles from the nearest potential (a)(2) water, and is not adjacent. The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3 (c)(1)(i)(ii)(iii) or (iv), and is therefore excluded per 33 CFR 328.3 (b)(1) as a non-adjacent wetland.
Wetland 03	0.03	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 03 is located in what appears to be an excavated cut area that was part of rough site grading around 2010. It is approximately 0.52 miles from the nearest potential (a)(2) water, and is not adjacent. The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3 (c)(1)(i)(ii)(iii) or (iv), and is therefore excluded per 33 CFR 328.3 (b)(1) as a non-adjacent wetland.
