Jay Ditch is a dashed blue-line on the U.S.G.S Quad that appears to begin at the southern boundary of the site. However this ditch appears to have been tiled decades ago. Site visit confirmed no stream features present on-site. The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3 (c)(1)(i)(ii)(iii) or (iv), and is therefore excluded per 33 CFR 328.3 (b)(1) as a non-adjacent wetland.
