Additional comments to support AJD: [In a FaceTime video tour of the site that occurred between the agent and USACE on 9/1/2020, it was evident that the review area had been cleared of trees to the stumps and that gravel was being stockpiled in the field areas. No evidence of a swale, gully, channel or any other potential aquatic resources was present in the review area, although a potential ephemeral channel appears to begin outside of the review area in the forested region to the east.](#)

⁵ Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
