Section II	0.03	acre(s)	(b)(1) Non- adjacent wetland.	Section II is a scrub-shrub wetland located in a depression in the west central portion of the parcel. The closest potential a(2) tributary appears to be Sand Creek located approximately 0.68 miles to the southeast. The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3 (c)(1)(i)(ii)(iii) or (iv),and is therefore excluded per 33 CFR 328.3 (b)(1) as a non-adjacent wetland.

The stormwater detention basin was excavated wholly in uplands sometime between 1985 and 1994 as seen in aerial imagery. The basin provides stormwater control for the site and adjacent developments. The site was entirely uplands for decades prior to the excavation of the detention basin.

This stormwater drain is an excavated stormwater conveyance on the north side of site.
