The approximately 4 acre review area contains a stormwater retention area on the north half of the site that was constructed in uplands in 2006, for the Bendix Corporation site. Two stormwater swales are present in the retention area. One swale flows into the retention area from the northwest corner, coming from another retention area located north of the Bendix building. Second swale flows into retention area from southwest coming from parking lot on east side of Bendix site. Requestor provided 2006 factory addition site plan showing retention area and swales. Review of desktop information shows this area was uplands prior to construction. One possible ephemeral swale may have been present in the area, but this feature would not have been jurisdictional. Therefore, the stormwater retention area and associated swales are excluded per 33 CFR 328.3(b)(10). There are no waters of the U.S. located in the review area.
