- C. **Additional comments to support AJD:** The identified wetland is located adjacent to Algonquin Parkway and is in the immediate vicinity of large industrial complexes that include, but is not limited to, Chevron Products company, Morris Forman Wastewater, Marathon Oil, and Zeon Chemical, LP. Based on desktop tools and provided photographs, there is no discernable aquatic input and/or output in relation to the wetland location indicating surface runoff and precipitation events to be the only hydrological input.
