### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

WL-03 (0.14 acre)

WL-03 is a scrub shrub wetland (PSS) with a farmed, saturated emergent fringe wetland located in the north center of the Survey Area. This wetland was not indicated on the NWI map. WL-03 receives hydrology from a high-water table and overland sheet flow from surrounding agricultural fields. WL-03 is isolated in the landscape with no signs of consolidated flow or a direct connection between the wetland and potentially jurisdictional resources. The wetland is approximately 900 feet from Flat Run, and outside the 100-year floodplain of the stream.

WL-10 (0.13 acre)

WL-10 is a PUB pond constructed in the uplands between 2008 and 2010 as indicated by aerial photography. WL-10 receives hydrology from a high-water table and overland sheet flow from surrounding agricultural fields. The feature is physically isolated in the landscape and does not connect to a downstream RPW or TNW.

WL-11 (0.05 acre)

WL-11 is a PUB pond located near the northwestern corner of the Survey Area. This wetland was indicated on the NWI map. WL-11 receives hydrology from a high-water table and overland sheet flow from surrounding agricultural fields. WL-11 is physically isolated in the landscape and had no outlet to downstream RPW or TNW.
