### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland 1 is located within an agricultural swale, approximately 1,300 feet from Stream 1. The wetland appears to have formed in an isolated low area within the swale, and there was no evidence that the wetland interfaced with a mapped buried drainage tile. Wetlands 2, 4, 6, and 7 are located in agricultural, isolated depressions. Wetland 5 is located in an isolated forested depression. Wetland 3 is located in a depressional area that collects regional flow. Aerials and NHD indicate drainage patterns running toward a railroad bed to the southwest; however, the 2014 and 2019 aerials show that drainage does not enter a discrete or defined ditch or channel of any sort. Flow appears to continue through overland, diffuse runoff through the adjacent agricultural field. There are no known surface or subsurface hydrologic connections from the wetlands, such as swales, drainage tiles, channels, etc., to any Waters of the U.S. (WOUS). Additionally, there are no known ecologic pathways or connections with any WOUS. Therefore, the wetlands in question are isolated, not susceptible to use in interstate or foreign commerce, and are not considered WOUS.
