C. Additional comments to support AJD: Cedar Creek is a highly manipulated channel. According to historic topographic maps, in 1967 Cedar Creek flowed south of Cedar Creek Road and no stream channels were identified on the north side of Cedar Creek Road within the review area. Between 1967 and 1979, there was road construction on Cedar Creek Road and Cedar Hills Drive that resulted in
