The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3 (c)(1)(i)(ii)(iii) or (iv), and is therefore excluded per 33 CFR 328.3 (b)(1) as a non-adjacent wetland.

The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3 (c)(1)(i)(ii)(iii) or (iv), and is therefore excluded per 33 CFR 328.3 (b)(1) as a non-adjacent wetland.
EPH-1	215	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	The reported ephemeral channel originates in the farm field and extends to the north before leaving the site. The channel has a faint bed and bank, which disappears when it leaves the site. No OHWM is apparent. StreamStats basin report indicates drainage area is 25 acres. The ephemeral channel/swale is excluded per 33 CFR 328.3 (b)(3).
