- B. Typical year assessment(s):** ATP data collected for June 21, 2021, two days prior to the site visit indicated that the site conditions of the June 23, 2021 were in the dry season with wetter than normal conditions.
- C. Additional comments to support AJD:** Section II and Section III were evaluated during the site visit on June 23, 2021 to determine flow regime. Both streams exhibited flow, traveling through small ravines and emptying into Clarks Creek. Source of hydrology appears to be directly from tile outlets from the adjacent field. Water was flowing during the site visit in each stream, however based on the ATP data, it was wetter than normal. Stream structure was fairly flat lacking primary indicators of sustained flow. Based on the APT data and observations made during the site visit, consider Sections II and III as ephemeral streams.
