C. Additional comments to support AJD: [UNT Buffalo Creek was determined to be an intermittent stream by the consultant because there was some water in the feature during the dry season and the USGS sheet from 1967 showed an intermittent stream in the area. The feature flows into a culvert and then into Wetland B. The USGS sheets from 1948 and 2019 do not show a steam in this area. Based on the photo in the waters report and the information cited above, the Corps has determined that this feature is a stormwater feature excavated to channel stormwater from the development on-site into roadside ditches \(Wetland B\).](#)
