Explain: **Three isolated wetlands (Wetland A - 0.190 acre PEM, Wetland B - 0.155 acre PEM, and Wetland C - 0.074 acre PEM) and one isolated ephemeral stream (Stream 1 - 88 LF) were identified in the 51.1 acre review area. The site consists of active agricultural crop ground and Wetlands A and B are located in depressional areas. Wetland B is located in a low-lying headwater area. The ephemeral channel starts at Wetland B and extends to the eastern site**

boundary. Due to a recent residential development to the east, no channel is present off-site. Review of aerials and other desktop information indicate that a defined channel was not present in this off-site location previously. The small ephemeral channel appeared to flow to the east/northeast and then lost bed and bank, becoming a grassed swale/waterway. No apparent defined channel was present for approximately 800-1000 feet, before the start of a likely tributary to Crooked Creek. As such, Wetland A, B, C, and the ephemeral stream have no hydrological connection to any downstream waters, are not located within the floodplain of any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. Therefore, the wetlands and stream are not waters of the U.S .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
