Explain: **Two isolated wetlands were identified in the review area. Wetland A - 1.25 acre (0.503 ac PEM, 0.613 ac PSS, 0.132 ac PFO) and Wetland B - 0.03 acre PFO are located in an isolated woodlot located in the southwest corner of the site. Wetland A is situated in a large depression and is separated from Wetland B by a large man-made historic berm. Wetland B was reported by the consultant to extend off-site to the west; however this could not be confirmed due to**

lack of site access. A grassed waterway/swale is present in some years of aerials extending from the woodlot to the west. The location of this swale is where an intermittent blue-line named Wesley Creek is shown on the U.S.G.S topo map. However, it appears any stream channel was tiled/filled decades ago because it cannot be observed on aerials. The swale extends west through crop field to an apparent wetland along the east side of German Church Road. A culvert is present conveying water under the road. A small channel with bed and bank starts at the culvert on the west side of road, extends southwest/west through a church property to the wooded floodplain of Indian Creek. Based on aerials and LiDAR, the channel appears to end in sheetflow, as no apparent channel can be seen connecting to Indian Creek. The wetlands in the review area are located over 2,700 feet from Indian Creek. Wetland A and B are not adjacent to any waters of the U.S., are not in any floodplain, are not hydrologically connected to any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. Therefore, Wetland A and B are not waters of the U.S..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
