There are no blue line streams indicated on topographic maps for the review area; however, the contour lines indicate a shallow draw separate from Stream 1. Photos submitted in the delineation show a defined bed/bank and the channel is filled with leaf litter and other vegetation. No flow was identified during the delineation site visit.
Stream 3	123	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	Stream 3 is a small channel that flows to the northeast to the confluence of Stream 1. There are no blue line streams indicated on topographic maps for the review area; however, the stream is located in the same draw as Stream 1. Photos submitted in the delineation show a defined bed/bank and the channel is filled with leaf litter. No flow was identified during the delineation site visit.
Stream 4	131	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	Stream 4 is a small channel that flows to the northwest to the confluence of Stream 1. There are no blue line streams indicated on topographic maps for the review area; however, the stream is located in the same draw as Stream 1. Photos submitted in the delineation show a defined bed/bank and the channel is filled with leaf litter. No flow was identified during the delineation site visit.
