Explain: **Six isolated emergent farmed wetlands were identified on the 16-acre site. These include Section I (0.06 acre), Section II (0.06 acre), Section III (0.08 acre), Section IV (0.06 acre), Section V (0.05 acre), and Section VI (0.09 acre). The closest tributary stream (Amity Ditch) is over 4,000 feet from the site. The wetlands are not located adjacent to any waters of the U.S., they do not have any hydrological connection to downstream waters, and are not susceptible for**

use in interstate or foreign commerce. Therefore the isolated wetlands are not waters of the U.S. Additionally, one man-made stormwater pond (0.97 acre) and man-made stormwater swale (373 LF) were identified on the site. The pond is located in the southeast corner of the site, and the swale extends from northwest of the review area, southeast across the site to the pond. Both the pond and swale were constructed wholly in uplands between 2007 and 2008 to provide stormwater control for the Ivy Tech parking lot to the northwest. There does not appear to be an outlet to the stormwater pond. The pond and swale are man-made features constructed in uplands and are therefore not waters of the U.S.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**
