C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Section I is a wetland that formed along a fence row in a depressional area adjacent to a row crop field. Section II formed as a result of a stormwater pond outfall on the western boundary of the review area. Water outfalls and surface flows across the agricultural field, where it is detained in a microdepression. Aerials indicate a general surface flow pattern across the field to a culvert under Jim Black Road/CR500E; however, there the flow appears to be from the immediately adjacent field. The delineation report noted the potential presence of a buried drainage tile under the wetland; however, there is no evidence of an inlet into the drainage tile system or definitive evidence of the presence and location of the tile. A land title survey and wetland delineation report (LRL-2020-957-MKD) of the parcel to the east, which includes Jim Black Road and its right-of-way within the review area, does not indicate the presence of a legal drain easement, tiles, or similar drainage structures that would potentially convey flow to Amity Ditch to the east. Review of historic aerials indicates the parcel was under successful agricultural production (i.e. does not appear to show potential wetlands or other waters). There are no known ecologic pathways or connections with any WOUS. Therefore, the wetlands in question are isolated, not susceptible to use in interstate or foreign commerce, and are not considered WOUS.
