- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **An emergent wetland, identified as W-A, is isolated because this feature lacks a connection to downstream waters. It is situated in a geographical depression lacking a connection to downstream waters. Open water aquatic resources identified as P-01, P-02, P-03, P-05, P-07, P-08, P-11, P-12, P-14, P-15, P-17, P-19, P-20, P-21, P-22, P-23, P-24, P-30, P-31, P-34, and P-35 are situated in a geographical depression lacking a connection to downstream waters. Direct precipitation and adjacent surface runoff appear to provide the primary source of hydrology. Therefore, the aforementioned aquatic resources do not possess any identifiable surface or shallow subsurface hydrological connections to a “waters of the United States (U.S).” They are not located in a floodplain and are not susceptible to use in interstate or foreign commerce. As such the above identified aquatic resources are not “Waters of the U.S.”.**

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on the submitted Wetland Delineation Report, the 21 ponds and one (1) wetland were determined to be non-jurisdictional due to an apparent lack of connection to TNWs via overland flow, NRPWs, or RPWs. These 22 features appear to be fully isolated. The ponds also appear to be constructed in uplands for agricultural purposes.
