Explain: **A site visit was conducted on November 9, 2021 by Corps' personnel to verify the jurisdictional statuses of aquatic resources within the boundaries of the identified location. A feature identified as 1MS1E displayed characteristics associated with an ephemeral tributary but goes subsurface prior to reaching the nearest "Water of the U.S.". A groundwater expression point could not be located in connection with the tributary. Direct precipitation and**

adjacent surface runoff appear to provide the primary source of hydrology. In addition three (3) wetlands, identified as 1MW3, 1MW7, and 1MW8, were identified on-site and determined to be isolated. The identified wetland features are situated in man-made depressions and lack a discernable connection to downstream waters. An open water aquatic resource identified as 1MO2 was also determined to be isolated. 1MO2 appears to have been constructed in the upland on a hillside slope and lacks any discernable connection to downstream waters. The aforementioned aquatic resources do not possess any identifiable surface or shallow subsurface hydrological connections to a "Waters of the U.S." The aquatic resources are not susceptible to use in interstate or foreign commerce and therefore not "Waters of the U.S."

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
