### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Ephemeral Stream 1 measures 221 linear feet and is located within the southeastern portion of the site and flows northeast. The stream loses a defined bed and bank within the project boundary and there is no evidence of flow from the stream consolidating further down slope within the project boundary

Ephemeral Stream 2 measures 74 linear feet and is located within the southeastern portion of the site and flows northeast towards Ephemeral Stream 1. The stream loses a defined bed and bank within the review area, and any flow from the stream would drain toward Ephemeral Stream 1, a non-jurisdictional feature isolated in the landscape.

Ephemeral Stream 3 measures 48 linear feet and is located within the eastern portion of the site and flows north before the channel loses a defined bed and bank. There is no indication of hydrology moving from the stream to Intermittent 1 which is approximately 250 feet away from the end of the channel, and the feature is isolated in the landscape.

Ephemeral Stream 4 measures 11 linear feet and is located within the eastern portion of the site and flows north before the channel loses a defined bed and bank. There is no indication of flow from the stream potentially reaching any downstream resources.

Wetland 1 measures 0.085 acre and is a forested wetland that has developed within an old pond. Wetland 1 is located in a depression in the landscape with no indication of an outlet which could provide a hydrological connection to downstream resources, and the feature is surrounded by upland forest.

The above features were identified within the review area and determined to be isolated in the landscape, have no hydrological or ecological connection to Waters of the U.S. and are not susceptible to use in interstate or foreign commerce.
