C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: An upland ditch was constructed in the agricultural field on the northern portion of the site sometime between 1962 and 1967. The approximately 1,300 linear foot ditch collects unconsolidated drainage along the embankment of Interstate 65 and drainage which runs along the south and wester side of S. Preston Highway, and a railroad which runs parallel to that road. Drainage along the road and railroad berms drains to a central low point where a culvert connects the upland ditch. There is no indication of hydrology from this upland ditch connecting to any downstream waters.

Hydrology from Wetland 4 drains west offsite toward the embankment of I-65. Unconsolidated flow was observed along the toe of the I-65 embankment which drains to the above-mentioned ditch. The ditch exhibits wetland characteristics within a forested area referred to a WET 5, but there is no indication of a connection to other aquatic resources. The ditch and two connected wetlands are physically isolated in the landscape and there is in no indication of a surface or shallow sub-surface connection to potentially jurisdictional waters.

A second surface connection exist between WET 6 and INT4. The feature lacks a defined bed and bank, and does not exhibit wetland characteristics, but does show provide a hydrologic connection between the two resources.

Open Water 1 is pond located in a depression in a forested area. There is no indication of an outlet, and the open water is physically isolated in the landscape.

Open Water 2 is in the middle of an agricultural field. The open water has no outlet, and is physically isolated in the landscape

Wetland 2 is located within an unimproved roadbed which runs through a forested area. Wetland indicators are confined to the small depressional bed, and there is no indication of a connection with surrounding resources. The wetland is located on a terrace approximate 20 feet above the elevation of Intermittent 3 and adjacent wetlands and tributaries. Wetland 2 is physically isolated in the landscape and there is in no indication of a surface or shallow sub-surface connection to potentially jurisdictional waterse.
