Explain: **Pond 1 (0.56 acre) is an isolated pond with no connection to downstream waters. Pond 1 is an agricultural pond located in a pasture. The pond is separated from an ephemeral stream by a dam/berm. Pond 1 has a spillway located in the northwestern corner of the pond that directs overflow to a pasture. The overflow dissipates in the pasture as sheetflow during overflow events. Pond 1 does not exhibit a hydrological or ecological connection to a TNW and is not susceptible to use in interstate or foreign commerce.**

Wetland E (0.02 acre) is an isolated wetland located along a pasture with no connection to downstream waters. Wetland E has developed within the borrow area created by the construction of a berm along the pasture and is separated from downstream waters by a berm and upland area. Wetland E does not exhibit a hydrological or ecological connection to a TNW and is not susceptible to use in interstate or foreign commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Section IV: Office does not concur with data sheets/delineation report - The submitted datasheets were acceptable, but the delineation report had discrepancies in regard to the connectivity/jurisdictional status of multiple waters (Pond 2, Wetland A, and Wetland B). These waters are not included on this approved jurisdictional determination, but were included in a preliminary jurisdictional determination.

Pond 1 and Wetland E are located in an active livestock pasture. Pond 1 drains via an overflow into the pasture and dissipates as sheetflow. The pond dam/berm is approximately 2-3 feet higher in elevation than the overflow. So even during extreme precipitation events, the flow is directed to the pasture by the overflow. Wetland E is located in a borrow area created by the construction of a berm along the edge of the pasture. Neither Pond 1 nor Wetland E exhibit hydrological or ecological connections to a TNW and are not susceptible to use in interstate or foreign commerce.
