C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The reported EPH-1 flows east to west across the site. The eastern portion of the swale appears to have been excavated from uplands sometime between 1985 and 1994. The western portion of the swale was excavated sometime around 2004. It conveys upland runoff to a stormwater pond west of the site outside the review area. Wetlands A and B are depressions that are impounded by infrastructure. Wetlands C and D and E and H (each respectively the same wetland, but labeled differently due to difference in vegetative cover type) formed along a former railroad bed in depression areas. Although there appears to be a remnant stormwater swale on the south side of the former railroad bed, there is no evidence that Wetlands B, C/D, or E/H flow outside of the review area due to lack of culvert or other conveyance under existing infrastructure on the west side of the review area. Wetland J formed in a stormwater ditch on the north side of the former railroad bed. Wetland G and F are agricultural depressions that do not flow outside their respective boundaries. The wetlands/swale in question are isolated, not susceptible to use in interstate or foreign commerce, and are not WOUS. .
