The UNT does not appear on USGS Topographic Maps and the surrounding area is relatively flat. The stream is filled with rip rap and vegetation is growing throughout the channel. There are several dam structures within the channel to hold water for the previous golf course. The ATP Tool describes conditions wetter than normal for the date provided from the photos, submitted by the applicant, that show shallow standing water upstream of each dam structure.
