Explain: One 5.36 acre pond and surrounding fringe wetland (WTLA - ~3.16 acre) were identified in the review area. The pond is a man-made borrow pit that was excavated for the construction of nearby I-465. An approved JD request was submitted in 2013, identifying the pond as a man-made pond constructed wholly in uplands and not connected to any waters of the U.S. The Corps and consultant visited the site on 15 APR 2014 and discussed that the pond was excavated in hydric soils, and there was not enough evidence to establish that the

pond was constructed wholly in uplands. It was also observed that there was one surface connection in the northeast corner of the pond, through a non-jurisdictional swale/roadside ditch that allowed the pond to overflow into Payne Branch, east of the site. No other connections between the pond and its surrounding wetland exist to downstream waters. The approved JD was subsequently withdrawn in 2014. In January 2015, the landowner obtained a storm water permit from the City of Indianapolis and constructed a berm in the non-jurisdictional swale, just outside the pond, severing the connection to downstream waters. The agent has now submitted a new approved JD request recommending that the pond and surrounding wetland are isolated. Storm water modeling submitted with the JD show that the top of berm is constructed 0.10 feet above the 100 year flood elevation, and therefore prevents any water from flowing to downstream waters of the U.S. Therefore, the pond and its surrounding fringe wetland are considered isolated and not waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
