of the wetland delineation report, the Corps made a site inspection on January 20, 2017. Some of the information provided on the data forms (vegetation data and soil data) appeared to be incorrect. Additionally, the boundaries of the wetlands did not appear to be exactly as reported. However, wetland parameters were identified in the area of the three wetlands, and they are isolated as reported. The wetlands are located within topographical depressions within the forested area. The forested area is located within a larger cemetery site which is surrounded on all sides by roads. The site is not located within any floodplain. There is no ecological or hydrological connection, or adjacency, to any waters of the U.S. The wetlands do not appear to be susceptible to use in interstate or foreign commerce. Therefore, Wetlands 1, 2, and 3 are isolated and not waters of the U.S. Additionally, the provided report identified one drainage feature on the site measuring 525 feet long. This drainage feature has a discontinuous bed and bank which originates from west of the review area. It extends eastward across the northern portion of the review area. Before reaching the eastern boundary of the review area, the drainage feature loses its bed/bank and flow dissipates as sheet flow across the upland site. The drainage feature does not have any hydrological connection to downstream waters of the U.S. Therefore, this drainage feature is not considered to be waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
