Explain: Two isolated wetlands totaling approximately 3.81 acres were identified within the review area, which includes two parcels totaling 23.77 acres. One isolated wetland is 0.81 acre PFO. The other isolated wetland measuring 3.00 acre consist of 1.0 acre PFO and

2.0 acre PEM. The wetlands identified are located in isolated depressions on the landscape and are not located adjacent to any waters of the U.S. Potential hydrological connection through subsurface tiles was evaluated by the consultant and Corps staff, however no definitive connection was found. A tile was located on the site by the consultant that appeared to be draining a portion of the upland ag field located south of the 0.81 acre wetland, but the tile was not near the identified wetlands and it was unclear where the tile drained to.

The larger 3.00 acre wetland on the site runs north-northeast along an old railway bed which forms the northern boundary of the site. The wetland boundary stops before a broad upland swale exits the site on the northeast corner. The swale proceeds off-site and may connect to an inlet connected to a county tile as identified by the consultant. In consultation with the county surveyor, it was identified that this county regulated tile may be located along Mt Comfort Road, which then runs north and northwest through agricultural farm fields, and then into a large retention pond. This retention pond then drains into another retention pond before exiting to Jay Ditch, 1 mile from the site. However, the county surveyor indicated they are not 100% certain on the location of the tile. Based on site observations, water within the wetland would have to rise several feet in order to exit into the upland swale and then flow offsite. There is no evidence that this occurs. If it did, water would then have to flow a distance of approximately 1 mile through a subsurface tile whose location is not accurately known, and through 2 retention ponds before entering a waters of the U.S. This connection is speculative. Additionally, the landscape between the wetlands on-site and the water of the U.S. is entirely row crop ag fields, so no ecological connection is present.

Based on all the available evidence and a thorough site investigation, there is no hydrological connection between the wetlands on-site and waters of the U.S. Additionally, the wetlands are not adjacent to any other waterbody and do not have an ecological connection to a waters of the U.S. Therefore, the wetlands on-site do not possess a significant nexus to a downstream TNW, and are considered isolated and jurisdiction is not being asserted.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.


