This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The reported 2.33 acre Wetland B consists of 1.01 acre of emergent wetland, 0.55 acre forested wetland, and 0.77 acre open water. The pond was constructed between 1967 and 1972 as a source of borrow for the construction of I-70. There is no outlet present that allows water to flow out of the pond, and it is not located within a floodplain. There are no other possible surface or subsurface hydrologic connections from the wetland, such as a swales, drainage tiles, channels, etc., to any Waters of the U.S. Additionally, there are no known ecologic pathways or connections with any Waters of the U.S. Therefore, the wetland in question is isolated with no hydrologic or ecologic connection to Waters of the U.S., and it is not susceptible to use in interstate or foreign commerce.
