The identified wetland is not located adjacent to, nor has any hydrological connection to any “waters of the U.S.” The wetland is located adjacent to a non-jurisdictional roadside ditch along SR38. The roadside ditch does not exhibit an ordinary high water mark, and ends in uplands to the west and east of the project limits. The wetland does not appear to be used, or susceptible to use for interstate or foreign commerce. Therefore, the wetland is considered isolated and jurisdiction is not being asserted.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
