determination are identified as Upland 1&2 and are the locations of the proposed rock check structures. Evidence of historical confined surface flow is not present at either of the sites and no defined bed/bank or OHWM are visible. The proposed quarry operation has been designed to avoid all WOUS. Based on these observations these two areas are considered upland areas with upland soils and vegetation, which is not within the jurisdiction of the Corps. The approximate center of Upland Area 1 can be found at Lat: 37.832119 Lon: -83.755664 The approximate center of Upland Area 2 can be found at Lat: 37.831892 Lon: -83.755556.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
