Explain: **The review area was visited by USACE staff who conducted an onsite assessment of the project area on March 2, 2016. During the visit, a review of the project area was conducted. USACE staff requested a wetland delineation in the area now identified as Upland Area #1. The consultant revisited the site and assessed the area for**

wetlands. Based on the site visit and the information provided by the consultant, the areas upslope of the limit of jurisdiction were determined to be uplands. The areas included in this approved jurisdictional determination are identified as Upland Area #1, Upland Area #2, and Upland Area #3 . No defined stream channels or evidence of historical confined surface flow was present at this site. No hydric soils were present at the site to indicate wetland formations. The site has been disturbed and reclaimed according to SMCRA standards, however the area was not proposed as a compensatory mitigation site. Further, Upland Areas #2 and #3 have been used as pastureland historically and are devoid of timber. Based on these observations and the information submitted to this office, these areas are considered upland areas with upland soils and vegetation, which is not within the jurisdiction of the Corps. The approximate center of Upland Area #1 is Lat: 37.459892, Lon: -83.783014 and includes 15 acres. The approximate center of Upland Area #2 is Lat: 37.463423, Lon: -83.780087 and includes 12 acres. The approximate center of Upland Area #3 is Lat: 37.463459, Lon: -83.777993 and includes 6.25 acres.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
