Explain: **Wetland 1 (6.68 acre) and Intermittent Stream 1 (712 linear feet) are physically isolated on the landscape with no surface or defined subsurface hydrological connection to "waters of the United States (U.S.)." The review area is located in an agricultural**

field. The scrub-shrub wetland is located within the boundary of the remnants of an old farm pond. Stream 1 drains the wetland and flows in a northern direction for 712 linear feet before flowing off the property. The intermittent stream channel continues northward approximately 1,600 linear feet through the agriculture field with approximately 750 linear feet in an underground tile drain. The stream exits the tiled drain and flows approximately 100 linear feet prior to flowing directly into a sinkhole. Known karst mapping does not demonstrate a defined connection to navigable waters. In addition, these features are not used or susceptible to use in interstate or foreign commerce. As such these features are not "waters of the U.S."

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:


