- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: The JD is for a man-made 38 acre open waterbody known as the Kokomo Waterworks Reservoir No.1. The reservoir was constructed in 1957 and is not fed by any waterbody. A review of historical aerials does not indicate that the reservoir was constructed in or captured any waters of the U.S. The reservoir is directly adjacent (separately by embankment/levee) to the Kokomo Waterworks Reservoir No. 2, which is an impoundment of Wildcat Creek, a waters of the U.S. It appears the subject reservoir was constructed entirely in the uplands along the bank of Wildcat Creek prior to impoundment for Reservoir No. 2. There is a pumping structure between the

subject reservoir and Reservoir No. 2, however it is reported to no longer be functional. Additionally, from pictures of the pumping structure, it appears water could only be moved between the two by pumping, and not by free flow of water. Essentially, the subject reservoir is not hydrologically connected to Reservoir No. 2. The 13 NOV 1986 preamble to 33 CFR Part 328.3 of the USACE implementing regulations states, "...we generally do not consider the following waters to be 'Waters of the United States.' (c) Artificial lakes or ponds created by excavating and/or diking dry land to retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing; and, (d) Artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating and/or diking dry land to retain water for primarily aesthetic reasons." The subject Reservoir No. 1 is a man-made lake constructed entirely in the uplands, is not hydrologically connected to a waters of the U.S., and does not appear susceptible to interstate or foreign commerce. Therefore, the subject reservoir is not considered to be a waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Essentially, the subject reservoir is not hydrologically connected to Reservoir No. 2. The 13 NOV 1986 preamble to 33 CFR Part 328.3 of the USACE implementing regulations states, “...we generally do not consider the following waters to be ‘Waters of the United States.’ (c) Artificial lakes or ponds created by excavating and/or diking dry land to retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing; and, (d) Artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating and/or diking dry land to retain water for primarily aesthetic reasons.” The subject Reservoir No. 1 is a man-made lake constructed entirely in the uplands, is not hydrologically connected to a waters of the U.S., and does not appear susceptible to interstate or foreign commerce. Therefore, the subject reservoir is not considered to be a waters of the U.S.
