Explain: A wetland delineation was conducted by the applicant on resources within the review area in the fall of 2016. Copies of the delineation were provided to the Corps in a December 22, 2016 request for jurisdictional determination. Fifteen forested wetlands and three open water resources were identified on the site as potentially isolated. A January 26, 2017 site visit was conducted by the Corps and the applicant. No precipitation had been recorded within the past 24 hours, however 0.52 inches were recorded within the past 9 days, and

standing water was observed in some low lying areas and swales within the review area helping in the identification of drainage patterns. Rainfall to date for the month of January was 2.48 inches which is 0.58 inches below the county average. During the site visit it was determined that the wetland resources were properly identified as they exhibited all three indicators of a wetland. No other potential aquatic resources were identified on-site that were not listed in the request for jurisdictional determination. The review area was accessed for signs of a nexus between the identified wetlands and the nearest TNW. The wetlands were determined not to be adjacent to the nearest TNW (the Ohio River), or directly abutting or adjacent to any RPW's that were identified on the site. The site is above the 100 year flood elevation of 337 feet at this reach of the Ohio River, and no RPWs were identified with the review area. One potentially jurisdictional RPW was identified outside the review area to the west of the site. This resource is an unnamed tributary to Little Bayou Creek. The stream originates at a wetland outside the review area and flows to the west away from the review area. The topography of the site creates a watershed break between this stream and identified wetlands within the review area. Potential non-RPWs were identified within and adjacent to the review area using aerial photography and ground reconnaissance. No wetlands within the review area were adjacent to or flowed directly into any non-RPWs. All potential non-RPWs within the review area, or having drainage patterns connected to the identified wetlands were examined and determined not to have a defined bed and bank, indicating a lack of regular channel forming flow. In general, all wetlands within the review area were depressional features surrounded by uplands. Wetland W-8 is adjacent to PUB-1. These resources, along with PUB 5 and 8, were found to be within a depression in the landscape and have no spillways or drainage patterns indicating any connection to another resources

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
