Contour maps show these wetlands to be located in an isolated depression, demonstrating that the wetlands are topographically isolated. Local county field tile maps show that the wetlands are not connected to Stony Creek through tiles. During field visit, Corps staff found no evidence of swales or outlets connecting the wetlands to any surrounding ‘waters of the U.S.’ Therefore, these wetlands do not possess any surface or subsurface hydrological connection to a waters of the U.S., are not located adjacent to any waters of the U.S., are not located in a floodplain, do not possess any ecological connection, do not capture or divert any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. As such, these isolated wetland are not waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
